OVERSEAS WARRANTY

1. GENERAL WARRANTY TERMS

- 1.01 GARDNER DENVER Srl guarantees the products sold from its catalogue <u>for 12 months starting</u> <u>from the date of purchase by the user, and within a maximum of 24 months from the date the product leaves the manufacturing plant (except for cases regulated by D.lgs. no. 24 of 2/2/2002 <u>implementing EU Directive 1999/44/EC)</u> as specified more in details for each line of products in the "Product-Specific Warranty Terms".</u>
- 1.02 Within the above mentioned time limits, GARDNER DENVER Srl shall, at its sole discretion, repair or replace, any part or component found to be defective in factory materials or workmanship. In no event shall GARDNER DENVER srl or its suppliers have liability for damages (including, without limitation, injuries, reduced or loss of earnings, business interruption, or other financial losses) resulting from the use of the products, even if GARDNER DENVER Srl is notified of the possibility of such damages.
- **1.03** WARRANTY on electrical parts is conditional upon the electrical part manufacturer recognising that warranty conditions are fulfilled.
- **1.04** In no event shall the WARRANTY cover ordinary maintenance services (oil change, cartridge, filter, belt replacement etc.).
- **1.05** GARDNER DENVER Srl shall not provide any WARRANTY unless the "WARRANTY REGISTRATION FORM" that comes with each compressor of our range is duly filled in by the Customer. Accordingly, no WARRANTY shall be provided if the Warranty Registration Form fails to reach GARDNER DENVER srl within 10 days from the installation/start-up of the new equipment.
- **1.06** The WARRANTY will not apply to damages/failure caused by: improper installation; no maintenance; tampering with the equipment or any of its components; use of lubricants other than

lubricants prescribed by GARDNER DENVER Srl in the accompanying User and Maintenance Manuals; improper use; standard wear; repair work carried out by people/workshops not authorized by GARDNER DENVER Srl.

- 1.07 Customers eligible for WARRANTY service are required to fill in fully the enclosed WARRANTY CLAIM FORM (specifying machine model, serial number, etc.) and to return it to the parent company. Should a claim concern a main part (screw assembly, electric motor, radiator, inverter, control unit, etc.), Gardner Denver Srl will supply a replacement part on a 'conditional sale' basis and will only apply the warranty terms if it finds the part to be defective upon inspection.
- 1.08 Shipping costs for Warranty repair equipment and/or parts will be borne by GARDNER DENVER Srl, whereas shipping costs for returning defective equipment and/or parts will be borne by the Customer.
- **1.09** These warranty terms only apply to products that are: manufactured by or on behalf of GARDNER DENVER Srl; are identified by a label on them indicating that this is a "BOTTARINI GARDNER DENVER PRODUCT"; and sold in Italy.

2. PRODUCT-SPECIFIC WARRANTY TERMS

- **2.01 LOW-PRESSURE PISTON COMPRESSORS:** WARRANTY shall cover <u>only defective parts</u> for 12 months, within a maximum of 24 months from the date the product leaves the GARDNER DENVER Srl manufacturing plant.
- **2.02 SCREW COMPRESSORS DRIVEN BY ELECTRIC MOTORS:** The 12-month WARRANTY covers replacement parts providing that the part is found be defective in factory materials or workmanship, and does not cover labour costs. WARRANTY shall not be provided if customer fails to sign and send the "Warranty Registration Form" to GARDNER DENVER Srl.
- 2.03 ENGINE-DRIVEN COMPRESSORS AND ELECTRO-COMPRESSORS FOR THE BUILDING INDUSTRY: The 12-month WARRANTY covers replacement parts providing the part is found be defective in factory materials or workmanship, and does not cover labour costs. Diesel engines are guaranteed by their respective Manufacturers assisted by their authorised workshops in Italy. Warranty terms for Diesel engines are specified in the engines' accompanying documentation (Important: Check the maximum number of hours prescribed by the manufacturer).

2.04 DRYERS, FILTERS AND ACCESSORIES The 12-month WARRANTY provides free replacement parts only for parts that are found to be defective, within a maximum of 24 months from the date the product leaves GARDNER DENVER Srl's warehouse.
